CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 5th day of November 2018 between the Municipality of Paniqui, represented by Hon. LEONARDO M. ROXAS, (hereinafter called the "Entity") and F.A. Asprer Construction of Phase II, Nina's Ville, Tarlac City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the project Design and Construction of Multi-Purpose Building, Gomez St., Brgy. Pob. Norte, Paniqui, Tarlac (hereinafter called the "Works") and the Entity has accepted the Bid for Forty Nine Million Nine Hundred Fifty Five Thousand Eight Hundred Ninety Two Pesos and 50/100 (P 49,955,892.50) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITHNESSETH AS FOLLOWS:

In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
