THIS AGREEMENT, made this 25th day of August 2020 between the Municipality of Paniqui, represented by Hon. LEONARDO M. ROXAS, (hereinafter called the "Entity") and Toyo Construction Builders & Services of Samput, Paniqui, Tarlac (hereinafter called the "Contractor").
