CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 24th day of September 2020 between the Municipality of Paniqui, represented by Hon. LEONARDO M. ROXAS, (hereinafter called the "Entity") and KENRYL Construction of #602 Dalayoan Subd., Pob. Sur, Paniqui, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the Concreting of Alley at Clark St. Brgy. Poblacion Sur, Paniqui, Tarlac (hereinafter called the "Works") and the Entity has accepted the Bid for Three Hundred Two Thousand One Hundred Eight Pesos and 55/100 (P 302,108.55) by the Contractor for the execution and completion of such Works with a contract duration of Sixty (60) days and the remedying of any defects therein.

NOW THIS AGREEMENT WITHNESSETH AS FOLLOWS:

The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
