CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 9th day of December 2020 between the Municipality of Paniqui, represented by Hon. LEONARDO M. ROXAS, (hereinafter called the "Entity") and 3K Builders of Nancayasan, Urdaneta City, Pangasinan (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Improvement of Local Access Road (Phase 1) at Barangay Acocolao*, *Paniqui*, *Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for Two Million Nine Hundred Ninety Seven Thousand Nine Hundred Ninety Four and 80/100 Pesos (P 2,997,994.80) by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITHNESSETH AS FOLLOWS:

 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (1) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
