EXECUTIVE ORDER NO 01, s. 2021

AN ORDER CREATING THE TASK FORCE FOR THE PROCUREMENT OF COVID-19 VACCINES IN THE MUNICIPALITY OF PANIQUI, TARLAC

WHEREAS, Republic Act No. 11494 or the "Bayanihan to Recover as One Act" authorizes the President to suppress the COVID-19 pandemic through the procurement of drugs and vaccines;

WHEREAS, Presidential Directive No. 2020-225, directing the Department of Health (DOH), DILG, and the Chief Implementer of the National Task Force Against Covid-19 to ensure the crafting of protocol on the administration of COVID-19 vaccines once available:

WHEREAS, the Department of the Interior and Local Government (DILG) has issued Memorandum Circular No. 2021-007 regarding the interim preparatory guidelines in the implementation of the National Vaccination Program;

WHEREAS, the national government will take the lead as the main procurer to ensure that the necessary monitoring and proper procedure must be followed to avoid duplication of efforts and ensure standardized and competitive pricing, thus, proper allocation will be done across the country;

WHEREAS, the DILG recommended that the procurement and roll-out of COVID-19 vaccine must be coordinated with the national government through the national task force and the Department of Health in a tripartite agreement involving local governments and pharmaceutical companies;

NOW, THEREFORE, I, LEONARDO M. ROXAS, Municipal Mayor of Paniqui in the Province of Tarlac, by virtue of the powers vested in me as Local Chief Executive, hereby order the creation Task Force for the Procurement of COVID-19 Vaccines in the Municipality of Paniqui, Tarlac.
