REORGANIZATION OF LOCAL DEVELOPMENT COUNCIL

WHEREAS, Art. 182, Rules and regulation implementing the Local Government Code of 1991 calls for the reorganization of the Local Development Council at all levels, the incumbent members of which is co-terminus with the previous administration.

WHEREAS, there is a need to provide a meaningful balance between democratic representation which favors a larger number of representation, and organization efficiency which favors a smaller number of representation;

WHEREAS, there is a need to further strengthen the local development councils to make them more efficient in accelerating economic and social growth and development at the local levels;

NOW, THEREFORE, in compliance with the above article, I, **LEONARDO M. ROXAS**, Municipal Mayor, do hereby proclaim that the order that:

Section 2. Development Plans. – That the Local Development Council shall initiate the formulation of a Comprehensive Multi-sectoral Development Plan to be approved by its Sanggunian.


Section 3. Duties and Functions – That the Local Development Council shall exercise the following functions:

1. Formulate long-term, medium term and annual socio-economic development plans and policies;
2. Formulate the medium term and annual public investment programs;
3. Appraise and prioritize socio-economic development programs and projects;
4. Formulate local investment incentive to promote inflow and direction of private investment capital;
5. Coordinate, monitor and evaluate the implementation of development programs and projects, and;
6. Perform such other functions as may be provided by the law or competent authority.

Section 4. Meetings – That the LDC shall meet once every six (6) months or as often as necessary. Quorum of the Committee meetings shall be one-half (1/2) plus one (1) of the total membership.

Section 5. This order shall take effect immediately.
