EXECUTIVE ORDER NO. 01, s.2019

"AN ORDER CREATING THE LOCAL GOVERNMENT UNIT PERFORMANCE CHALLENGE FUND PROJECT IMPLEMENTATION UNIT FOR F.Y. 2019 (LGU PCFPIU)"

WHEREAS, the Philippine Development Plan 2017-2022 gives importance on the promotion of effective and honest governance, the Department of Interior and Local Government (DILG) initiated the implementation of the Performance Challenge Fund (PCF);

WHEREAS, the PCF recognizes the Local Government Units (LGU) by rewarding them with incentives or grants based on local governance, compliance with policies, public disclosure and performance;

WHEREAS, the PCF encourages the junction of local development projects with the national government thrusts and goals consistent with the provisions of the General Appropriations Act of 2018;

WHEREAS, the recipient LGUs of PCF Grants shall comply with the requirements of the Memorandum of Agreement (MOA) with the DILG and ensure that the project proposals shall conform to the existing national standards and guidelines;

NOW, THEREFORE, I, LEONARDO M. ROXAS, Municipal Mayor, by virtue of the power vested upon me by law do hereby direct and order the following:

SECTION 2. Function.

1. Monitor and evaluate the implementation of the PCF funded program and submit status reports to the DILG.
2. Submit documentary requirements;

For Infrastructure Projects: Project proposal, Program of Work, Detailed Cost Estimate, Detailed Engineering Design, Bar Chart/S-curve, Pictures of proposed site, and other administrative requirements as required by the DILG for the Issuance of Notice to Implement (NTI).

For procurement of Vehicle/ Equipment: Pictures of proposed project, Motor/Vehicle Inventory Form, Specifications and Cost of Vehicle/Equipment, Inventory and Inspection report of Unserviceable Vehicle/Equipment, and other pertinent documents as required by the DILG for the Issuance of Notice to Implement (NTI).


3. Ensure the completeness of all engineering designs, plans, specifications, etc. related to the constructions, installation, operations and maintenance of agricultural, aquaculture and fishery, and forest product machinery, agricultural buildings and structures, irrigation and drainage systems, farm to market roads, post-harvest facilities etc. shall be signed and sealed by registered agricultural engineer as required pursuant to item e), Section 21, RA 8559 (Philippine Agricultural Engineering Act of 1998) and item 4.9 of DILG Memorandum Circular No. 2008-167 implementing certain provisions of RA 8559.
4. Endorse the LGU's proposed project under the PCF indicated in the Annual Investment Plan and Annual Procurement Plan of the Municipality.
5. Implement the LGU PCF funded project within one (1) year from the date of receipt of the PCF Check.

SECTION 3. Meetings. The LGU PCFPIU shall meet at least once a month, or as often as may be necessary.

SECTION 4. Effectivity. This executive order takes effect immediately.
