**EXECUTIVE ORDER NO.10, s.2022**

**REORGANIZATION OF EXECUTIVE AND SECTORAL COMMITTEES IN THE  
LOCAL DEVELOPMENT COUNCIL**

**WHEREAS**, Section 111 (a) of RA 7160 provides for the creation of an Executive Committee to represent and act in its behalf when the Local Development Council is not in session;

**WHEREAS**, Section 112 of RA 7160 provides the legal basis of the Local Development Council to form sectoral or functional committees to handle social, economic, infrastructure, environment and development administration concerns whose composition shall be determined by the LDC;

NOW, THEREFORE, I, LEONARDO M. ROXAS by virtue of the authority vested in me by law do hereby order the following:

**Section 1: Composition of Executive Committee.**

**Section 2: Functions and powers of Executive Committee.**

1. Ensure that the decisions of the council are faithfully carried out and implemented;
2. Formulate policies, plans and programs based on the general principles laid down by the council;
3. Act on matters requiring immediate attention or action by the council; and
4. Act on other matters that may be authorized by the council.

**Section 3: Meeting:** The Executive Committee shall meet once a month to determine that the policies, plans and programs of the council are carried out in accordance with the agreed principles. Quorum shall be determined with the presence of at least two-thirds (2/3) of the members in attendance.

**Section 5:** Duties and Responsibilities of the Sectoral Committee shall include the following:

1. Perform a supportive function to the Local Development Council;
2. Review and evaluate matters pertaining to their respective sectors and endorse the same to the LDC Execom or to the LDC full council.
3. Integrate sectoral plans and programs of local government units and coordinate all sectoral planning and programming activities of the sector;
4. Review and endorse programs/projects of local government units requiring LDC support;
5. Integrate sectoral information and statistics in preparation of the annual development report;
6. Assist the council in the translation of barangay and municipal development goals and policies into specific sectoral objectives;
7. Facilitate and coordinate project preparation, implementation and monitoring within the sector;
8. Perform other functions as may be assigned by the council proper, or upon instruction of the Execom Chairman.

**Section 6:** Meeting. Sectoral Committee shall meet before the conduct of a full council meeting, held twice a year as mandated by the Local Government Code. Quorum of Executive and Sectoral Committee meetings shall be one-half (1/2) plus one (1) of the total membership.

**Section 7.** Effectivity. This order takes effect immediately.
