### EXECUTIVE ORDER NUMBER 13 Series of 2020

#### AN ORDER RECONSTITUTING THE LOCAL VERIFICATION COMMITTEE OF THE MUNICIPALITY OF PANIQUI, TARLAC

**WHEREAS**, the Listahanan or the National Household Targeting System-Poverty Reduction project of the Department of Social Welfare and Development will be conducting the Validation and Finalization Phase for second of CY 2020 to assess and verify preliminary list of poor households and the correctness of entries in the database and shall maintain the system and serve as repository of the data on poor households, which shall be used by NGAs in prioritizing beneficiaries of government's social protection programs and projects which shall update the data every four (4) years; and

**WHEREAS**, Local Government Units shall organize its respective Local Verification Committee who shall assist in the implementation of household assessment.

**NOW THEREFORE**, I, **LEONARDO M. ROXAS** Municipal Mayor of Paniqui, Tarlac, by the virtue of the powers vested in me by the Constitution and Laws, do hereby declare that:

Section 1. **COMPOSITION.** The Local Verification Committee of Paniqui, Tarlac shall be composed of the following:

#### Section 2. **FUNCTIONS, DUTIES AND RESPONSIBILITIES**

The Local Verification Committee of Paniqui shall perform the following:

- a. Resolve all the complaints and or appeals brought by individuals and or groups;
- b. Identifies households that have not been assessed based on appeals and complaints received.
- c. Certify the correctness or incompleteness of the List of Households living below the poverty threshold along with the recommended changes.

Section 3. This order supersedes previous issuances, which are inconsistent herewith.


