**EXECUTIVE ORDER NO. 13, s.2022**

**REORGANIZATION OF LOCAL HEALTH BOARD (LHB)**

WHEREAS, Article 185 of the Rules & Regulation implementing the Local Government Code of 1991 calls for the reorganization of the Local Health Board at all levels, the incumbent members of which is co-terminus with the previous administration.

NOW, THEREFORE, in compliance with the above provision of the law, I, **LEONARDO M. ROXAS**, Municipal Mayor, do hereby proclaim and order:

Section 1. *Composition* — That the reorganization of the Local Health Board with the following composition:

Section 2. *Duties and Functions* — That the Local Health Board shall exercise the following functions:

1. Propose to the Sangguniang concerned, in accordance with the standards & criteria set by DOH, Annual Budget Allocations for the operation and maintenance of health facilities and services within the Municipality.
2. Serve advisory committee to the Sangguniang concerned on health matters such as, but not limited to, the necessity for, and application of local appropriations for the public health purposes; and

3. Create committees which shall advise, local health agencies on matters such, but not limited to, technical and administrative standards of DOH, personnel selection and complaints, personnel discipline, budget review, operations review and similar functions.

Section 3. *Meetings* — The board shall meet once every six (6) months or as often as maybe necessary.

Section 4. This Order shall take effect immediately.
