**REORGANIZATION OF LOCAL DEVELOPMENT COUNCIL**

**Section 2.** Development Plans. – That the Local Development Council shall initiate the formulation of a Comprehensive Multi-sectoral Development Plan to be approved by its Sanggunian.


**Section 3.** Duties and Functions – That the Local Development Council shall exercise the following functions:

1. Formulate long-term, medium term and annual socio-economic development plans and policies;
2. Formulate the medium term and annual public investment programs;
3. Appraise and prioritize socio-economic development programs and projects;
4. Formulate local investment incentive to promote inflow and direction of private investment capital;
5. Coordinate, monitor and evaluate the implementation of development programs and projects, and;
6. Perform such other functions as may be provided by the law or competent authority.

**Section 4.** Meetings – That the LDC shall meet once every six (6) months or as often as necessary. Quorum of the Committee meetings shall be one-half (1/2) plus one (1) of the total membership.

**Section 5.** This order shall take effect immediately.
