EXECUTIVE ORDER NO 16, s. 2020

RE-CONSTITUTING THE COMMITTEE ON ANTI-TRAFFICKING AND ANTI-VIOLENCE AGAINST WOMEN AND CHILDREN

WHEREAS, Joint Memorandum circular No. 2010-01 dated October 18, 2010 of DILG, DSWD and DOJ mandates local government units to create of local committees on anti-trafficking and violence against women and children;

WHEREAS, the purpose of said joint memorandum is to establish and strengthen a local structure that will collaboratively address the problem of trafficking of and violence against women and children;

NOW, THEREFORE, I, LEONARDO M. ROXAS, Mayor of the Municipality of Paniqui, by virtue of the powers vested in me by the law, do hereby order the creation of the committee on anti-trafficking of and antiviolence women and children.

Section 1.Composition. The committee on anti-trafficking of and anti-violence against women and children shall be composed of:

Section 2. Duties and Functions. The committee shall perform the following duties and functions;

- 1. Institute policies and programs to protect women and children who are victims of trafficking and violence,
- 2. Create and establish system on surveillance, investigation and rescue to ensure effective and establish coordination;
- 3. Undertake information education and advocacy campaign against trafficking of persons and VAWC;
- 4. Monitor and oversee the strict implementation of Republic Act Nos.9208 and 9262 and other related laws for the protection of women and children and of the interagency committee on anti-trafficking and inter-agency committee on violence against women and children national plans of actions;
- 5. Implement the programs and activities aligned with the national plan of action against VAWC;
- 6. Perform other duties and functions necessary to carry out above duties and functions.

Section 3. The Committee here in created shall meet at least once a month or as often as it may deem necessary. The presence of the Chairman and majority of the members shall constitute a quorum to transact official business.

Section 4. The Municipal Social Welfare and Development Office shall serve as Secretariat of the Committee and shall be responsible for the documentation of activities and proceedings of the same.

Section 5. Effectivity. This executive order shall take effect immediately.
