EXECUTIVE ORDER NO. 2 Series of 2020

AN ORDER CREATING THE "DISPLINA MUNA TASK FORCE" OF THE MINICIPALITY OF PANIQUI, TARLAC

WHEREAS, Section 16, Article X of the 1987 Philippine Constitution promotes the right of the people and their organizations to effective and reasonable participation at all levels of social, political, and economic decision-making;

WHEREAS, Section 16 of Republic Act No. 7160 or the Local Government Code of 1991 states that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as power necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare.."

WHEREAS, Section 34, Chapter IV of the Local Government Code of 1991 states that LGUs shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, the Department of the Interior and Local Government (DILG), through Memorandum Circular No. 2019-181 dated October 24, 2019, providing details and guidelines for the government-wide national advocacy campaign for a culture of discipline dubbed as "Disiplina Muna";

WHEREAS, there is a need to align the efforts of the Municipal Government of Paniqui, Tarlac to promote a culture of discipline within the Municipality with the national campaign, "Disiplina Muna" in support of the program of the national government;

NOW THEREFORE, I, LEONARDO M. ROXAS, Mayor of the Municipality of Paniqui, Tarlac vested in me by existing laws, do hereby order the creation of Disiplina Task Force with the following provisions:

SECTION I- COMPOSITION

SECTION II - DUTIES AND RESPONSIBILITIES

- 1. Ensure the effective, efficient and coordinated implementation of the programs, project, policies and activities that serve as the pillars of the Disiplina Muna campign, as well as enabling pertinent local rules, ordinance and legislation, to wit:
 - a. Traffic Management including, but not limited to, the Paniqui, Tarlac, Traffic Ordinance;
 - b. Road clearing including, but not limited to, Memorandum Circular No. 2019 121 dated July 29, 2019, and all other regulations issued by the Department of Public Works and Highways (DPWH) and the Land Transportation Office (LTO):
 - c. Prohibition on Sidewalk Vending including, but not limited to, the Paniqui, Tarlac Market Code and the Paniqui, Tarlac Traffic Ordinance;
 - d. Anti-Littering including, but not limited to, the Municipality of Paniqui Anti-Littering Ordinance:
 - e. Anti-Smoking including, but not limited to, Executive Order No. 26 issued by President Rodrigo Duterte; and Executive Order No. 054 s.2017,
 - f. Disaster Prepared and Resilience including, but not limited to, the DILG Operation Listo, which aims to promote and ensure disaster preparedness among LGUs at three levels: Listong Pamilyang Pilipino, Listong Paamayanan, and Listong Pamayanang Lokal;
 - g. Other programs aimed at promoting public order, safety, cleanliness, and the general welfare of the people of Paniqui, Tarlac
- 2. Formulate plans and policies that will ensure public safety, cleanliness, peace and order in all public areas, spaces, economic enterprises, roads and thoroughfares within the jurisdiction of the Municipality of Paniqui Tarlac;
- 3. Undertake operations and apprehension activities in line with the abovementioned programs;
- 4. Facilitate coordination among key offices, agencies, establishment and organizations;
- 5. Regularly update the Chief Executive as regards such operations, activities and coordination efforts:
- 6. Perform other tasks that may be assigned by the Chief Executive from time to time.

SECTION III- EFFECTIVITY

These order shall take effect upon its signing.

SECTION IV - REPEALING CLAUSE

All Executive Orders, rules, and regulations and other issuances or parts thereof, which are inconsistent with this Executive Order are hereby revoked, amended, or modified accordingly.
