REORGANIZATION OF THE LOCAL SCHOOL BOARD

WHEREAS, Article 184 of the Rules & Regulation implementing the Local Government Code of 1991 calls for the reorganization of the Local School Board at all levels, the incumbent members of which is co-terminus with the previous administration;

NOW, THEREFORE, in compliance with the above provision of the law, I, LEONARDO M. ROXAS, Municipal Mayor, do hereby proclaim and order:

Section 1. Composition —That the reorganization of the Local School Board with the following composition:

Section 2. Duties and Functions — The function of the school board shall:

1. Determine in accordance with the criteria set by DepEd, the Annual/supplemental budgetary needs for the operation and maintenance of public schools within the municipality, and the supplementary local cost of meeting such needs, which shall be reflected in the form of an annual school board budget corresponding to its share of the proceeds of the special levy on real property constituting the special education fund and such other sources of revenue as the code and other laws or ordinances may provide;

2. Authorize the Municipal Treasurer to distribute funds from the special education fund pursuant to the budget prepared in accordance with applicable existing rules & regulations;

3. Serves as Advisory Committee to the sangguniang concerned on educational matter such as, but not limited to the necessity for the uses of the local appropriations for educational purposes; and

4. Recommend changes in the names of public schools within the territorial jurisdiction of the LGU for the enactment by the sangguniang concerned.

Section 3. Meetings —That the LDC shall meet once every six (6) months or as often as necessary.

Section 4. This Order shall take effect immediately.
