"CREATION OF GENDER AND DEVELOPMENT MONITORING AND EVALUATION (GAD M&E) TEAM"

WHEREAS, Philippine Commission on Women (PCW), Department of the Interior and Local Government, Department of Budget and Management, and National Economic and Development Authority Joint Memorandum Circular (JMC) No. 2013-01, as amended, entitled, "Guidelines on the Localization of the Magna Carta of Women" provides that all Local Government Units (LGUs) shall create and maintain a gender responsive Monitoring and Evaluation (M&E) System;

WHEREAS, to ascertain the GAD project's success in achieving its targets and goals, assess practices and processes, and cull important lessons from the experiences and problems encountered by the project;

WHEREAS, the creation of the GAD M&E Team would provide recommendations on the areas for pprovement to make the project gender-responsive or more gender-responsive;

Section 2. FUNCTIONS. The GAD M&E Team shall:

- a) Monitor the implementation of GAD-related programs, activities and projects in their respective offices and suggest corrective measures to improve implementation of GAD PAPs and GFPS activities;
- b) Prepare and consolidate agency GAD accomplishment and evaluation reports; and
- c) Provide regular updates and recommendations to the GADFPS Chairman or Executive Committee on the activities of the GADFPS and the progress of agency GAD mainstreaming activities based on the feedback and reports of the various units of the LGU.

SECTION 3. Meetings. The GAD M&E Team shall meet quarterly, or as often as may be necessary.

SECTION 4. Effectivity. This executive order takes effect immediately.
