**EXECUTIVE ORDER NO 30, s. 2019**

**REORGANIZING THE PROJECT MONITORING COMMITTEE OF THE  
MUNICIPALITY OF PANIQUI, TARLAC**

**WHEREAS**, Executive Order No. 376 and 93 as amended provide for the creation of Project Monitoring Committee (PMC) at the provincial, city and municipal levels;

**WHEREAS**, there is a need to organize the PMC to monitor and evaluate the implementation of various local government projects funded from national government and local government funds including foreign assisted projects whether grant or loan;

**WHEREAS**, the PMC in the execution of its duties and functions shall develop overall monitoring and evaluation system based on the criteria, standards and principles of monitoring and evaluation system designed by the National Economic Development Authority (NEDA);

**NOW, THEREFORE, I, LEONARDO M. ROXAS**, Municipal Mayor of the Municipality of Paniqui, by virtue of the power vested in me by law, do hereby order the creation of the Project Monitoring Committee.

**Section II. Functions of Project Monitoring Committee**

- Provide system for the integration, coordination, linkage of all monitoring activities in the municipality;
- Process and provide up to date information on all the overall status of the project implementation of each department for planning and decision making;
- Identify problems/issues which impede project implementation for remedial actions and elevate unresolved issues and problems to the Office of the Mayor for resolution and final action;
- Provide information on lessons learned in project implementation for planning and implementation of future similar projects;
- Assess and ascertain whether projects implemented are supportive of municipal development goals and plans as well as national development thrusts and priorities;
- Present the consolidated Monitoring and Evaluation Report to provide the Local Chief Executive Management information regarding the implementation of local development projects; and
- Submit quarterly monitoring and evaluation report to the LCE for action.



**Section IV. Funding** – Funds for various PMC activities which include trainings, coordination, meetings, and preparation of reports among others shall be allocated by the municipal government to ensure efficient operation of the committee.

**Section V. Effectivity** – This Executive Order shall take effect immediately.
