Section 2. Function of the Council

- 1. To formulate tourism related programs that will support socio-economic development of the municipality.
- 2. To attract foreign and local tourists to engage in activities and projects promoting the growth of tourism.
- 3. To expand the livelihood and employment opportunities brought by tourism related businesses.
- 4. To man the Tourism Information Center that will cater all tourist inquiries.
- 5. To protect the environment and other natural resources from abuse and pollution brought by both foreign and local interventions.

Section 3. Roles and Responsibilities of Tourism Officer

- 1. Over-all supervision of the operations and activities of the Tourism Council in the implementation and coordination of marketing activities and projects of the LGU.
- 2. Coordination and establishing network with local and foreign tourist authorities with regard to tourism, among others.
- 3. Provide marketing support to the Tourism Council.
- 4. Submission of periodic financial statements and liquidation reports.
- 5. Custody of all personnel and general records, office equipment and supplies in the Tourism Office and Tourist Information Center.
- 6. Maintenance of Tourism Office and Tourist Information Center.

Section 4. The Municipal Tourism Council shall meet at least once a month, or as often as may be necessary

Section 5. Effectivity. This executive order takes effect immediately.
