**EXECUTIVE ORDER NO 05, s. 2020**

**RECONSTITUTION OF THE PROJECT MONITORING COMMITTEE, INSPECTORATE TEAM AND PROJECT IMPLEMENTATION TEAM OF THE MUNICIPALITY OF PANIQUI, TARLAC**

**WHEREAS**, Executive Order No. 376 s. 1989 establishing the regional project monitoring and evaluation system (RPMES) and for other purposes to facilitate project implementation and devolve facilitation, problem solving, monitoring and evaluation of foreign, national and locally funded projects to the sub-national levels.

**WHEREAS**, as provided in the aforementioned Eos, Project Monitoring Committee (PMCs) originally established as the monitoring arm of the Local Development Councils under Memorandum Order No. 175 dated May 23, 1988 were tapped to operationalize the RPMES at sub regional level;

**WHEREAS**, there is a need to reconstitute the Project Monitoring Committee and reorganize the inspectorate team to continue exercising the duties of monitoring inspection of all projects being implemented within the Municipality;

**WHEREAS**, the reorganization of the Project Implementation Team is also necessary to ensure the quality and safety required for the implementation of projects in the Municipality;

**NOW, THEREFORE, I, LEONARDO M. ROXAS**, Municipal Mayor of the Municipality of Paniqui, by virtue of the power vested in me by law, do hereby ordain and decree that;
