EXECUTIVE ORDER NO. 06, s.2019

RE-ORGANIZATION OF LOCAL CULTURE AND ARTS COUNCIL

WHEREAS, Section 16 of the Local Government Code of 1991 provides that local government units play an important role in the development and preservation of Filipino identity.

WHEREAS, the Municipality endeavors to keep with the Filipino identity to encourage the participation of the community in the development and preservation of artistic, historical and cultural heritage;

WHEREAS, historical and cultural heritage and resources promotes patriotism and nationalism, induce cultural unity, and encourage public awareness and cultural values;

WHEREAS, such cultural development for three hundred seven (307) years of municipal government existence needs to be sustained and be enriched as it clearly contributes to the progress of the men and women of Paniqui;

WHEREAS, under Book III. Title 2.Chapter 2. Article 3, Section 447-XVII of the Local Government Code of 1991, the Local Chief Executive shall establish a Municipal Council whose purpose is the promotion of culture and arts;

NOW, THEREFORE, I, LEONARDO M. ROXAS, by virtue of the authority vested in me by law as Mayor of the Municipality of Paniqui do hereby order the following:

Section 1: Composition - There is hereby created a Local Council for Culture and the Arts (LCCA) in the Municipality of Paniqui.

Section 2: Functions - The Local Council for Culture and the Arts shall have the following functions:

- a. Prepare an annual plan on culture and the arts consonant to the Medium Term Philippine Development Plan for Culture and the Arts, to be integrated in the local development plan.
- b. Formulate programs and recommendations to develop local cultural and artistic talents.
- c. Ensure the protection, preservation and conservation of the local cultural and historical heritage.
- d. In coordination with the private sector, conduct cultural events such as cultural festivals, competition, lectures, seminars, fora and symposia; set up exhibits during fiestas and other related activities.
- e. Conduct periodic consultations with all stakeholders to identify grassroots-based cultural concerns, issues and agenda.
- f. Encourage the development of local cultural industries.
- g. Conduct periodic inventory of Local cultural objects and sites in coordination with the National Commission for Culture and the Arts.
- h. Coordinate with existing Local Culture and the Arts Councils.

Section 3. Meetings - The Municipal Tourism Council shall meet at least once a month, or as often as may be necessary

Section 4. Effectivity - This executive order takes effect immediately.
