CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 27th day of July 2022 between the Municipality of Paniqui, represented by Hon. LEONARDO M. ROXAS, (hereinafter called the "Entity") and AMARDEX DRUG STORE of # 600 Purok 1, Brgy. Balayang, Victoria, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Procurement of various Medicine and Medical, Supplies for Paniqui General Hospital, LGU-Paniqui, Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for Nine Hundred Eighty Eight Thousand & Thirteen Pesos (Php 988,013.00) by the Contractor for the execution and completion of such Works with the contract duration of fourteen (14) days.

The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
