CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 17th day of October 2022 between the Municipality of Paniqui, represented by HON. LEONARDO M. ROXAS, (hereinafter called the "Entity") and PNQ GENERAL MERCHANDISE of Unit 1, ICF Bldg., Burgos St., Brgy. Tablang, Paniqui, Tarlac (hereinafter called the "Contractor").
