CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 3rd day of November 2022 between the Municipality of Paniqui, represented by HON. LEONARDO M. ROXAS, (hereinafter called the "Entity") and ZI-ON CONSUMER GOODS TRADING of Barangay Southwest Poblacion, Nampicuan, Nueva Ecija (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the Supply and Delivery of various Office Equipment and Supplies for Paniqui General Hospital, LGU-Paniqui, Tarlac (hereinafter called the "Works") and the Entity has accepted the Bid for Four Hundred Ninety Nine Thousand Nine Hundred Pesos Only (Php 499,900.00) by the Contractor for the execution and completion of such Works with the contract duration of Fifteen (15) days.

 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (1) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
