CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 6th day of **December 2022** between the Municipality of Paniqui, represented by **Hon. LEONARDO M. ROXAS**, (hereinafter called the "Entity") and **AMARDEX DRUG STORE** of # 600 Purok 1, Brgy. Balayang, Victoria, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Procurement of One (1) Set 5KW Portable X-Ray Machine, Paniqui General Hospital, LGU-Paniqui, Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for **One Million Eight Hundred Eighty One Thousand Pesos (Php 1,881,000.00)** by the Contractor for the execution and completion of such Works with the contract duration of Twenty (20) Days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.





BAC RESOLUTION NO. 025 series of 2022

WHEREAS, the Municipality of Paniqui advertised the Invitation to Apply for Eligibility and to bid of the **Procurement of One (1) Set 5KW Portable X-Ray Machine, Paniqui General Hospital, LGU-Paniqui, Tarlac** by posting the notice of bidding in the PHILGEPS, Bulletin Board and other conspicuous place in the premises of the LGU continuously for 26 days;

WHEREAS, in response to the said advertisements, One (1) supplier submitted letter of intent and applications for eligibility. The suppliers purchased bid documents but only one bidder submitted its bid and was found eligible on November 28, 2022;
