CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 21st day of March 2021 between the Municipality of Paniqui, represented by Hon. LEONARDO M. ROXAS, (hereinafter called the "Entity") and 3K BUILDERS of Nancayasan, Urdaneta City, Pangasinan (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the Construction of Drainage Canal (Phase 2) at Caburnay St., Brgy. Pob. Sur, Paniqui, Tarlac (hereinafter called the "Works") and the Entity has accepted the Bid for Five Million One Hundred Forty Thousand Sixty and 92/100 Pesos (P 5,140,060.92) by the Contractor for the execution and completion of such Works with a contract duration of one hundred eighty (180) days.

NOW THIS AGREEMENT WITHNESSETH AS FOLLOWS:

The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
