## **CONTRACT OF AGREEMENT**

THIS AGREEMENT, made this 27<sup>st</sup> day of April 2021 between the Municipality of Paniqui, represented by Hon. LEONARDO M. ROXAS, (hereinafter called the "Entity") and JAM-C BUILDERS of # 193 Orchid St., Brgy. Salapungan, Villa Soliman Subd., National Highway, Tarlac City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the Construction of Two (2) Storey Multi-Purpose Bldg. at Brgy. Mabilang, Paniqui, Tarlac (hereinafter called the "Works") and the Entity has accepted the Bid for Two Million Four Hundred Forty Nine Thousand Pesos (P 2,449,000.00) by the Contractor for the execution and completion of such Works with a contract duration of one hundred twenty (120) days.

  - (1) Other contract documents that may be required by existing laws and/or the Entity.

The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
