

CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 27th day of **August 2021** between the Municipality of Paniqui, represented by **Hon. LEONARDO M. ROXAS**, (hereinafter called the "Entity") and **ROGENOX CONSTRUCTION AND SUPPLY CORPORATION** of 1011 Bonifacio St., Tayug, Pangasinan (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Construction of Covered Court, Barangay Colibangbang, Paniqui, Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for **Three Million Eight Hundred Seventy Nine Thousand Twenty Three Pesos & 93/100 (P 3,879,023.93)** by the Contractor for the execution and completion of such Works with a contract duration of one hundred fifty (150) days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity covenants to pay the Contractor in consideration of the execution and




