CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 11th day of January 2022 between the Municipality of Paniqui, represented by Hon. LEONARDO M. ROXAS, (hereinafter called the "Entity") and R.R. RICAFORT CONSTRUCTION & SUPPLIES of Mac Arthur Highway, Brgy. Parsolingan, Gerona, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the Construction of New Public Market - Wet Section Bldg., Phase 1 at Burgos St., Brgy. Tablang, Paniqui, Tarlac (hereinafter called the "Works") and the Entity has accepted the Bid for Thirty Four Million Nine Hundred Eighty Thousand Pesos (P 34,980,000.00) by the Contractor for the execution and completion of such Works with a contract duration of five hundred forty (540) days.

NOW THIS AGREEMENT WITHNESSETH AS FOLLOWS:

 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (1) Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
