#### **CONTRACT OF AGREEMENT**

THIS AGREEMENT, made this 18<sup>th</sup> day of November 2022 between the Municipality of Paniqui, represented by HON. LEONARDO M. ROXAS, (hereinafter called the "Entity") and TOYO CONSTRUCTION BUILDER & SERVICES of Barangay Samput, Paniqui, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Installation of Street Lighting, Barangay Balaoang, Paniqui, Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for Nine Hundred Sixty Seven Thousand Sixty Five Pesos Only (P 967,065.00) by the Contractor for the execution and completion of such Works with a contract duration of Thirty (30) days.
