### **RESOLUTION NO 122 - 2011**

On motion of councilor Rosauro V. Tayag, properly seconded, resolved, as it is hereby resolved, to approved an ordinance requiring all motorized tricycles which are legally granted with MTOP by this municipality to secure a reflectorized body plate from the treasury office and shall thereto steadily fasten on the sidecar's front exterior body panel".

RESOLVED FRUTHER that this resolution be enacted into an ordinance to wit.

## **MUNICIPAL ORDINANCE 2011 - 007**

AN ORDINANCE REQUIRING ALL MOTORIZED TRICYCLES WHICH ARE LEGALLY GRANTED WITH MTOP BY THIS MUNICIPALITY TO SECURE A REFLECTORIZED BODY PLATE FROM THE TREASURY OFFICE AND SHALL THERETO STEADILY FASTEN ON THE SIDECAR'S FRONT EXTERIOR BODY PANEL

Be it ordained by the Sangguniang Bayan of Paniqui, Tarlac in session assembled, that:

#### **SECTION 1. DEFINITION OF TERMS**

- a. OPERATORS OF TRICYCLES FOR HIRE as used in this ordinance shall mean all Tricycle For-Hire Operators required under existing laws & appropriate ordinances to secure and/or renew a MTOP as a prior condition to its operations within the territorial jurisdiction of the municipality except those private or not for hire tricycles.
- b. REFLECTORIZED BODY PLATE as used in this ordinance shall mean an embossed plate showing that a particular tricycle is a legitimate and duly registered tricycle-for-hire operating within the territorial jurisdiction of the municipality to be secured from the Municipal Treasury Office
- c. VALIDATING STICKERS as used in this ordinance shall mean a legitimate sticker printed by the local government unit showing that the REFLECTORIZED BODY PLATE of a particular tricycle-for-hire has been duly renewed for the ensuing fiscal year or every so often as required by existing laws and appropriate ordinance.

SECTION 2. All operators of Tricycles-For-Hire plying their route within the territorial jurisdiction of the municipality of Paniqui are hereby required to register and secure a TRICYCLE BODY PLATE upon payment of corresponding fees for the following year or so often from the Municipal Treasury Office.



SECTION 3. The REFLECTORIZED BODY PLATE which shall cost <u>TWO HUNDRED</u> <u>SEVENTY FIVE PESOS (P275.00)</u> each shall be valid for a period of <u>ONE (1) year</u> from its issuance unless altered, defaced or damaged in such a way that it shall become ineligible. Once issued, such <u>REFLECTORIZED BODY PLATE</u> shall be validated for the ensuing year and every so often through the issuance of a printed <u>VALIDATION STICKER</u> which shall cost <u>TEN PESOS (P10.00) each</u> affixed to such registration plate.

**SECTION 4.** Upon securing such REFLECTORIZED BODY PLATE from the Treasury Office, the Tricycle operator shall *steadily fasten the same on the sidecar's front exterior body panel* to be readily seen or viewed by the public in order to facilitate the proper identification of any unauthorized or colorum tricycles which shall enable the proper designated authorities to enforce applicable laws and appropriate ordinances.

SECTION 5. That in the event the cost of production of the REFLECTORIZED BODY PLATE shall increase, the municipal treasurer shall within fifteen (15) days from notice of such increase cause thru the office of the mayor the immediate adoption of an ordinance providing for such increase provided, however, he/she may continue collecting and accepting reflectorized body plate fee at the current prevailing rate from the applicant/s and the increment shall be collected upon approval of the ordinance and issuance of the new plate. Provided, further, that the cost of REFLECTORIZED BODY PLATE shall remain the same until all plates are disposed.

**SECTION 6.** Upon its approval, the Municipal Mayor, with due recommendation from the Municipal Treasury Office shall issue appropriate guidelines and implementing rules to ensure the proper implementation of the provisions of this ordinance.

**SECTION 7.** Any operator/driver found violating any of the provisions of this ordinance shall be punished by a fine not exceeding **ONE THOUSAND PESOS (P1,000.00)**.

SECTION 8. This ordinance shall take effect upon approval.
