WHEREAS, the Municipality of Paniqui, Tarlac is a beneficiary of Bayanihan Grant to Cities and Municipalities (BGCM);

WHEREAS, as per Local Budget Circular # 125 dated April 7, 2020 the Department of Budget and Management (DBM), a Special Account in the General Fund (SAGF) for the BGCM shall be created through an Ordinance by the Local Sanggunian pursuant to Section 313 of RA No. 7160;

NOW THEREFORE, on motion of Councilor Javerne C. Santillan, unanimously seconded, RESOLVED, as it is hereby Resolved, to create a **Special Account in the General Fund (SAGF)** for the **Bayanihan Grant to Cities and Municipalities (BGCM)**.

RESOLVED FURTHER, that this resolution be enacted into an ordinance to wit:

ORDINANCE NO. 003-s2020

AN ORDINANCE CREATING SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF) FOR THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCM).


Be it ordained by the Sangguniang Bayan of Paniqui, Tarlac that:

Section 1. **Special Account in the General Fund (SAGF)** for the **Bayanihan Grant to Cities and Municipalities (BGCM)** is hereby **created** as required by the Department of Budget and Management (DBM) Local Budget Circular (LBC) # 125 dated April 7, 2020 for easy monitoring/tracking of the utilization of the allocation of the BGCM to the municipality of Paniqui, Tarlac.

Section 2. This ordinance shall take effect upon its approval.


