RESOLUTION NO. 099-s2020

On motion of Councilor Mary Anne B. Fernandez, duly seconded by Councilor Nestor B. Castro, RESOLVED, as it hereby Resolved, to amend as it hereby amends certain provisions of **Municipal Ordinance No. 006-s2020–Municipality of Paniqui Ecological and Integrated Solid Waste Management Ordinance of 2020.**

RESOLVED FURTHER, that this resolution be enacted into an ordinance, to wit;

ORDINANCE NO. 007-s2020

“AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 006-S2020-MUNICIPALITY OF PANIQUI ECOLOGICAL AND INTEGRATED SOLID WASTE MANAGEMENT ORDINANCE 2020 INTENSIFYING THE IMPLEMENTATION OF THE NO SEGREGATION NO COLLECTION POLICY; SUBJECT TO ALL PROMULGATED RULES AND PROCEDURES.”

BE IT ORDAINED By the Sangguniang Bayan of Paniqui, Tarlac in session duly assembled: to amend **Article 8, Article 20 and Article 23** of Ordinance No. 006- Series of 2020 entitled “Municipality of Paniqui Ecological and Integrated Solid Waste Management Ordinance of 2020”;

SECTION 1. Section 20 of Article 8 *Maintenance of Clean Frontage and Immediate Surroundings* shall contain an additional paragraph to read as follows:

Section 20. All person covered by this chapter are required to report and coordinate to the MSW office within 24 hours from time to time for accumulation of bulky wastes or construction/demolition debris in their property, yard or immediate area for the collection and disposal of such wastes. ***All barangays should include provisions of Article 8 in their SWM policies and impose penalties for violations thereof.**

SECTION 2. Paragraph under Section 51 of Article 20 *Solid Waste Management Fees* shall be amended to read as follows:


Section 51. Fee for Households – *Households shall pay a monthly solid waste management fee as maybe promulgated under every barangays SWM policies or ordinances in categories a Sangguniang Barangay deem fit and necessary subject to all existing guidelines.

SECTION 3. Section 62 of Article 23 *Collection of Disposition and Fines* shall contain an additional paragraph to read as follows:


Section 62. The payment of fines for violation of this Ordinance shall be at the Municipal Treasurer's Office *except penalties the different barangays may collect as maybe provided in their SWM and Revenue Ordinances subject to all existing rules and regulations.

SECTION 4. This Ordinance takes effect upon approval
