ORDINANCE NO. 2007-08

(Ordinance No 7-Amended Series of 1992)

AN ORDINANCE PROHIBITING THE SALE, DISPOSAL, OR DRINKING BY ADULTS, OF SPIRITITED, FERMENTED OR INTOXICATING LIQUOR, WINE, OR THE LIKE, FROM CERTAIN HOURS.

Be it ordained by the Sangguniang Bayan of Paniqui that:

Section 1. No store, restaurant, refreshment or recreational establishment owner and/or operator or any person to that effect, shall sell or dispose to any person spirited, fermented, or intoxicating liquor, wine or the like, from 1:00 A.M. to 6:00 AM.

Section 2. Notwithstanding the provisions of the preceding sections any owner and or operator of store, restaurant, refreshment, or recreational parlor shall be allowed to sell or dispose to any person, 18 years of age or above, spirited, fermented or intoxicating liquor, wine or the like, drinking of the same by customers shall be without the time limit during social occasions at the public auditorium or elsewhere within the jurisdiction of this municipality.

Section 3. Any person who violates this Ordinance shall be subjected to the following fines.

 $\begin{array}{c} 1^{st} \mbox{ offense} - 500.00 \mbox{ Pesos} \\ 2^{nd} \mbox{ offense} - 1,000.00 \mbox{ Pesos} \\ 3^{rd} \mbox{ offense} - 2,000.00 \mbox{ Pesos} \\ 4^{th} \mbox{ offense} - suspension \mbox{ of business operation within 30 days} \end{array}$

Section 4. All ordinances inconsistent or in conflict herewith are hereby repealed, amended or modified accordingly.

Section 5. This ordinance shall take effect upon the approval of the Sangguniang Bayan of Paniqui, Tarlac
