RESOLUTION NO. 93-2007

On motion of Councilor Sergio Baltazar, unanimously seconded, RESOLVED, as it is hereby Resolved to amend as it hereby amends Ordinance No 08 (as amended series of 2006) “An ordinance prohibiting the sale, disposal, or drinking by minors, of spirited, fermented or intoxicating liquor, wine or the like;

RESOLVED FURTHER that this resolution be enacted into an ordinance to wit;

ORDINANCE NO. 2007-09
(Ordinance No. 8 amended series of 2006)

AN ORDINANCE PROHIBITING THE SALE, DISPOSAL, OR DRINKING BY MINORS OF SPIRITED, FERMENTED OR INTOXICATING LIQUOR, WINE OR THE LIKE.

Be it ordained by the Sangguniang Bayan of Paniqui, Tarlac that:

Section 1. No store, restaurant, refreshment or recreational establishment owner and or operator or any person to that effect, shall sell or dispose to any person below 18 years of age spirited, fermented or intoxicating liquor, wine or the like.

Section 2. No persons below 18 years of age, shall drink or take any kind of spirited, fermented or intoxicating liquor, wine or the like in any store, restaurant, or refreshment or recreational establishment, or in any public place within the jurisdiction of this municipality.

Section 3. Any person who violates this ordinance shall be subjected to the following fine.

- 1st offense – 500.00 Pesos
- 2nd offense – 1,000.00 Pesos
- 3rd offense – 2,000.00 Pesos
- 4th offense – Suspension of business operation within 30 days

Section 4. All ordinances inconsistent or in conflict herewith are hereby repealed, amended or modified accordingly.

Section 5. This ordinance shall take effect upon the approval of the Sangguniang Bayan of Paniqui, Tarlac
