RESOLUTION NO. 092 - 2009

On motion of councilor Aniel Bon C. Santillan, unanimously seconded, resolved, as it hereby resolved, to adopt, as it hereby adopts and implement the Citizen's Charter of the Municipal Government of Paniqui, Tarlac pursuant to Republic Act No. 9455, otherwise known as the Anti-Red Tape Act of 2007

RESOLVED FURTHER, that this resolution be enacted into an ordinance, to wit;

ORDINANCE NO. 2009 - 009

AN ORDINANCE ADOPTING AND IMPLEMENTING THE CITIZEN'S CHARTER OF THE MUNICIPAL GOVERNMENT OF PANIQUI, TARLAC PURSUANT TO REPUBLIC ACT NO. 9455, OTHERWISE KNOWN AS THE ANTI-RED TAPE ACT OF 2007.

Be it ordained by the Sangguniang Bayan of Paniqui, Tarlac that:

SECTION 1. TITLE

"This Ordinance shall be known as the Citizen's Charter Ordinance of the Municipality of Paniqui"

SECTION 2. POLICY

It is hereby declared the policy of the Municipal Government of Paniqui to promote integrity and accountability of its public officials and employees and exercise transparency in the manner of transacting business with the general public by minimizing red tape and prevent graft and corruption.

SECTION 3. DECLARATION OF PRINCIPLES

The enactment of this ordinance is anchored in, and its implementation shall be guided by the following principles:

- a. Transparency in government decision making and administration requires information openness on matters involving the affairs of government;
- b. Information openness ensures transparency that effectively enforces accountability of a public officers;

SECTION 4. COVERAGE

This Ordinance shall apply to all officials and employees of departments, agencies, divisions and units of the Local Government of Paniqui which provide frontline services to the general public.

SECTION 5. DISSEMINATION

The Local Government of Paniqui shall be responsible for the dissemination and introduction of the Citizen's Charter to all its constituents in the municipality.

SECTION 7. SEPARABILITY CLAUSE

Should any provision of this ordinance be declared invalid or unconstitutional by any court of competent jurisdiction, portions not so declared shall remain in full force and effect.

SECTION 7. EFFECTIVITY

This Ordinance shall take effect immediately upon its approval.
