**RESOLUTION NO. 017 - 2011**

**WHEREAS**, Section 447 (a) sub-paragraph (1) of the Local Government Code of 1991 provides that the Sangguniang Bayan, as the legislative body of the municipality, shall enact ordinances for the general welfare of the municipality and its inhabitants and in the proper exercise of the corporate powers of the municipality. “(ii) Maintain peace and order by enacting measures to prevent and suppress lawlessness, disorder, xxx and impose penalties for the violation of said ordinances”

**WHEREAS**, pawnshops, some financial institutions and other big scale establishments are imminent targets of criminal elements which may result in the destruction of lives and properties and economic instability;

**WHEREAS**, to deter occurrences of robbery or hold-up on pawnshops, other financial institutions and some big establishments, close circuit televisions (CCTV) must be installed inside and outside its premises.

**WHEREAS**, camera is a vital tool in the identification of the perpetrators of crimes and indubitable proof and effective deterrent to the commission of crime;

**NOW THEREFORE**, on motion of Councilor Evelyn S. David, unanimously seconded, **RESOLVED** as it is hereby **RESOLVED**, to enact an ordinance requiring all commercial and institutional establishment within the municipality of Paniqui to put up a Centralized Circuit Television (CCTV) facilities within their premises;

**RESOLVED FURTHER** that this resolution be enacted into an ordinance, to wit:

**ORDINANCE NO. 2011-005**

**AN ORDINANCE REQUIRING ALL COMMERCIAL AND INSTITUTIONAL ESTABLISHMENT WITHIN THE MUNICIPALITY OF PANIQUI TO PUT UP A CENTRALIZED CIRCUIT TELEVISION (CCTV) FACILITIES WITHIN THEIR PREMISES TO DETER AND/OR RECORD THE COMMISSION OF CRIMES AT THEIR VICINITY.**

Be it ordained by the Sangguniang Bayan of Paniqui, Tarlac in session assembled, that:

**SECTION 1.** All commercial and institutional establishments within the municipality of Paniqui with an investment of at least Two Million (P 2,000,000.00) pesos are hereby mandated to install CCTV inside and outside their respective premises within ninety (90) days from approval of this ordinance.

**SECTION 2.** For the purpose of this ordinance the following terms are hereby defined as follows:

2.1 *Close Circuit Television* - a unit containing an imaginary device that produced a video signal in a basic band witch.

2.2 *Commercial Establishment* - shall include all the supermarkets, department stores and others.

2.3 *Institutional Establishment* - shall include pawnshop, money lending institutions, financial cooperative, money changing centers, collection agencies and the likes that store large amount of money used for the financial activities such as granting loans, receiving or collecting payments and remittances, and foreign currency exchange centers among others.

**SECTION 3.** Preservations of Camera Recording – commercial and institutional establishment shall preserve the camera recordings for at least a period of one (1) year of its recording.

**SECTION 4.** Commercial and institutional establishments shall make available the camera recording to the authorities engage in the crime investigation upon written request stating the purpose thereof.

**SECTION 5.** Banks Secrecy - Prohibits unauthorized and/or unofficial use or viewing of any saved or archive video recordings and unauthorized disclosure or identification of the identity of any person, clients seen on video other than the complainants or victims.


**SECTION 6.** Penalty – The commercial and institutional establishment which fail to comply the provisions of Section 1 hereof shall be fined One Thousand Two Hundred pesos per day (P 1,200/day) after complied with. If the provisions of Section 3 and 4 are violated, the violator shall be fined P Two Thousand Five Hundred Pesos (P 2,500). The Municipal Mayor may withhold the issuance of Mayor’s Permit to offer its business in Paniqui, Tarlac of any violators of this ordinance.


**SECTION 7.** Separability - If any provisions of this ordinance is held invalid or unconstitutional, other provisions not affected hereby shall remain valid and subsisting.

**SECTION 8.** Effectivity - This Ordinance shall take effect immediately after 30 days upon its approval and publications in a newspaper of local circulation.
