A RESOLUTION APPROVING THE MUNICIPAL JUVENILE INTERVENTION PROGRAM OF THE MUNICIPALITY OF PANIQUI, TARLAC.

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code of 1991 mandates the Local Governments to promote the general welfare of their inhabitants, provide basic services for their constituents which shall ensure the effective and efficient delivery of such services;

WHEREAS, the Juvenile and Welfare Council created by virtue of Republic Act 9344 provides the Comprehensive National Juvenile Intervention Program framework to ensure the efficient implementation and to serve as guide for LGUs in the preparation of their intervention and diversion programs for Children in Conflict with the Law;

WHEREAS, Section 18 of RA 9344 requires LGUs to develop a Comprehensive Local Juvenile Intervention Program (CLJIP) covering at least a 3-year period and set aside an amount necessary to implement said program;


NOW THEREOFRE, on motion of **Councilor Mary Anne B. Fernandez**, duly seconded by Councilor Rachilda Myra O. Garcia, **RESOLVED**, as it is hereby Resolved, to **approve and adopt** as it hereby **approves and adopts**, the **Comprehensive Local Juvenile Intervention Plan of the Municipality of Paniqui, Tarlac.**

RESOLVED FURTHER, to append copies of the project proposal and draft Memorandum of Agreement (MOA) as an integral part of this resolution.


RESOLVED FINALLY, that a copy of this resolution be furnished to all offices and agencies concerned for information and appropriate action.
