“A RESOLUTION ADOPTING **REPUBLIC ACT NO. 11188** AN ACT FOR THE SPECIAL PROTECTION OF CHILDREN IN SITUATION OF ARMED CONFLICT.


WHEREAS, it is hereby declared the policy of the State to provide special protection to children in situations of armed conflict, from all forms of abuse, violence, cruelty, discrimination, neglect, abuse, exploitation and other acts prejudicial to their interest, survival, development and well-being, taking into consideration their gender, cultural, ethnic and religious background, consistent with the United Nations Guiding Principles on Internal Displacement, the United Nations Security Council Resolutions related to children affected by armed conflict;

NOW THEREFORE, on motion of **Councilor Felomina F. Bravo**, duly seconded by Councilor Nestor B. Castro, RESOLVED, as it is hereby Resolved, to adopt **Republic Act No. 11188** an *Act Providing for the Special Protection of Children in Situations of Armed Conflict* also known as “SPECIAL PROTECTION OF CHILDREN IN SITUATIONS OF ARMED CONFLICT ACT”.
