
TEMPORARY FARE RATE INCREASE OF TRICYCLES FOR HIRE OPERATING WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF PANIQUI, TARLAC.

WHEREAS, pursuant to Presidential Proclamation No. 929, Series of 2020, which declared a State of Calamity throughout the Philippines due to the Coronavirus Disease 2019 (COVID-19), the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines ("OG") dated 29 April 2020, and in view of the current COVID-19 public health situation and the extended implementation of the Enhance Community Quarantine (ECQ) and General Community Quarantine (GCQ) in specified areas, Tricycle Operators and Drivers were among the affected sectors in the municipality of Paniqui;

WHEREAS, the Sangguniang Bayan Committee on Transportation and the Tricycle Operators and Drivers Association (TODA) convened for a meeting and after a conscientious deliberation on the matter the Committee has taken into consideration the request of the TODA for a Temporary Increase of Tricycle Fare for them to cope up with the present public health situation in accordance with the omnibus guidelines for tricycle passenger regulation;

NOW THEREFORE On motion of Councilor Christian Alfred F. Cuchapin, duly seconded by Councilor Robert J. Torio, RESOLVED, as it is hereby Resolved, to approve the temporary increase of tricycle fare, to wit:
