“A RESOLUTION ADOPTING REPUBLIC ACT NO. 10666 AN ACT PROVIDING FOR THE SAFETY OF CHILDREN ABOARD MOTORCYCLES ALSO KNOWN AS “CHILDREN’S SAFETY ON MOTORCYCLES ACT OF 2015”.

WHEREAS, it is the policy of the State to defend the right of children to assistance, including proper care and nutrition, and special protection from all forms of neglect, abuse, cruelty, exploitation, and other conditions prejudicial to their development.


WHEREAS, towards this end, the State shall pursue a more proactive and preventive approach to secure the safety of passengers, especially children, by regulating the operation of motorcycles along roads and highways.

NOW THEREFORE, on motion of **Councilor Felomina F. Bravo**, unanimously seconded, RESOLVED, as it is hereby Resolved, to adopt **Republic Act No. 10666, an Act Providing for the Safety of Children Aboard Motorcycles also known as “CHILDREN’S SAFETY ON MOTORCYCLES ACT OF 2015”.**


RESOLVED FURTHER, that copies of this resolution be furnished all offices and other agencies concerned for their information and appropriate action.


