

**BAC Resolution Declaring SCRB and Recommending Approval**

WHEREAS, in response to the said advertisements, one (1) bidder/supplier submitted letter of intent and applications for eligibility. The supplier purchased bid document and was found eligible on February 13, 2023;

WHEREAS, the bidding documents were submitted on February 13, 2022 and the lone bidder passed the preliminary examination of bids;





## CONTRACT OF AGREEMENT

**THIS AGREEMENT**, made this 20<sup>th</sup> day of **February 2023** between the Municipality of Paniqui, represented by **HON. LEONARDO M. ROXAS**, (hereinafter called the "Entity") and **PNQ GENERAL MERCHANDISE** of Unit 1, ICF Bldg., Burgos St., Brgy. Tablang, Paniqui, Tarlac (hereinafter called the "Contractor").

**WHEREAS**, the Entity is desirous that the Contractor execute the *Procurement of various ICT Equipment, LGU-Paniqui, Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for **Four Hundred Three Thousand Eight Hundred Twenty Four Pesos Only (Php 403,824.00)** by the Contractor for the execution and completion of such Works with the contract duration of Twenty (20) days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Notice of Award of Contract and the Bidder's conforme thereto;
  - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.




