

BAC Resolution Declaring SCRB and Recommending Approval

BAC RESOLUTION NO. 016 series of 2023

WHEREAS, the Municipality of Paniqui advertised the Invitation to Apply for Eligibility and to bid of the **Procurement of various Drugs & Medicines for RHU-I, RHU-II and PGH, LGU-Paniqui, Tarlac** by posting the notice of bidding in the PHILGEPS, Bulletin Board and other conspicuous place in the premises of the LGU continuously for 26 days;

WHEREAS, in response to the said advertisements, One (1) supplier submitted letter of intent and applications for eligibility. The suppliers purchased bid documents but only one bidder submitted its bid and was found eligible on March 8, 2023;

WHEREAS, the bidding documents were submitted on March 8, 2023 and the lone bidder passed the preliminary examination of bids;

WHEREAS, the bid proposal of the bidder was found to be substantially complying:

- b) To recommend for approval by the Municipal Mayor of the Municipality of Paniqui, Tarlac the foregoing findings.







CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 16th day of **March 2023** between the Municipality of Paniqui, represented by **Hon. LEONARDO M. ROXAS**, (hereinafter called the "Entity") and **AMARDEX DRUG STORE** of # 600 Purok 1, Brgy. Balayang, Victoria, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Procurement of various Drugs & Medicines for RHU-I, RHU-II and PGH, LGU-Paniqui, Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for **Three Million Two Hundred Eighteen Thousand Seven Hundred Seventeen Pesos Only (Php 3,218,717.00)** by the Contractor for the execution and completion of such Works with the contract duration of Fourteen (14) Days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conformer thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


