WHEREAS, the bidding documents were submitted on February 28, 2023 and the lone bidder passed the preliminary examination of bids;


WHEREAS, the bid proposal/s of the bidders was found to be substantially complying:







## CONTRACT OF AGREEMENT

**THIS AGREEMENT**, made this 8<sup>th</sup> day of **March 2023** between the Municipality of Paniqui, represented by **HON. LEONARDO M. ROXAS**, (hereinafter called the "Entity") and **CUADRA'S EVENT CATERING SERVICES** of San Fernando, Victoria, Tarlac (hereinafter called the "Contractor").

**WHEREAS**, the Entity is desirous that the Contractor execute the *Meals & Snacks for the Celebration of the 311th Founding Anniversary of LGU-Paniqui, Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for **Two Hundred Ninety Nine Thousand Two Hundred Fifty Pesos Only (Php 299,250.00)** by the Contractor for the execution and completion of such Works with the contract duration of Seven (7) days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - (f) Bid Data Sheet;
  - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Notice of Award of Contract and the Bidder's conforme thereto;
  - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.






