

**BAC Resolution Declaring SCRB and Recommending Approval**

**BAC RESOLUTION NO. 032 series of 2023**

WHEREAS, the Municipality of Paniqui advertised the Invitation to Apply for Eligibility and to bid of the **Procurement of Mathematics Books for Child Development Centers, MSWDO, LGU-Paniqui, Tarlac** by posting the notice of bidding in the PHILGEPS, Bulletin Board and other conspicuous place in the premises of the LGU continuously for 26 days;

WHEREAS, in response to the said advertisements, One (1) supplier submitted letter of intent and applications for eligibility. The supplier purchased bid documents and the lone bidder submitted its bid and was found eligible on June 14, 2023;

WHEREAS, the bidding documents were submitted on June 14, 2023 and the lone bidder passed the preliminary examination of bids;

## CONTRACT OF AGREEMENT

**THIS AGREEMENT**, made this 21<sup>st</sup> day of **June 2023** between the Municipality of Paniqui, represented by **HON. LEONARDO M. ROXAS**, (hereinafter called the "Entity") and **JERICOPIM PUBLISHING HOUSE, INC.** of Purok 6, Sapang, Jaen, Nueva Ecija (hereinafter called the "Contractor").

  - (k) Notice of Award of Contract and the Bidder's conforme thereto;
  - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


