

**BAC Resolution Declaring SCRB and Recommending Approval**

**BAC RESOLUTION NO. 034 series of 2023**

WHEREAS, the Municipality of Paniqui advertised the Invitation to Apply for Eligibility and to bid of the **Procurement of various ICT Equipment & Office Supplies for Local School Board, Paniqui West District Schools, Paniqui, Tarlac** by posting the notice of bidding in the PHILGEPS, Bulletin Board and other conspicuous place in the premises of the LGU continuously for 26 days;

WHEREAS, in response to the said advertisements, One (1) supplier submitted letter of intent and applications for eligibility. The supplier purchased bid documents and the lone bidder submitted its bid and was found eligible on June 20, 2023;

WHEREAS, the bidding documents were submitted on June 20, 2023 and the lone bidder passed the preliminary examination of bids;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED as it is hereby RESOLVED:





## CONTRACT OF AGREEMENT

**THIS AGREEMENT**, made this 29<sup>th</sup> day of **June 2023** between the Municipality of Paniqui, represented by **HON. LEONARDO M. **WHEREAS**, the Entity is desirous that the Contractor execute the *Procurement of various ICT Equipment & Office Supplies for Local School Board, Paniqui West District Schools, Paniqui, Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for **Seven Hundred Seventy Eight Thousand Four Hundred Eighty Nine Pesos Only (Php 778,489.00)** by the Contractor for the execution and completion of such Works with the contract duration of Thirty (30) days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Notice of Award of Contract and the Bidder's conforme thereto;
  - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


