CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 13th day of **October 2023** between the Municipality of Paniqui, represented by **HON. LEONARDO M. ROXAS**, (hereinafter called the "Entity") and **CABAYAOASAN FARMERS AGRICULTURE COOPERATIVE** of Sitio Masuri, Brgy. Cabayaosan, Paniqui, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Supply and Delivery of 446 sacks of Rice (25kg) for the One-Time Grant of Rice Assistance to All Government Employees, LGU-Paniqui, Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for **Five Hundred One Thousand Seven Hundred Fifty Pesos Only (Php 501,750.00)** by the Contractor for the execution and completion of such Works with the contract duration of **Fourteen (14) days**.

 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.


