

**BAC Resolution Declaring SCRB and Recommending Approval**

**BAC RESOLUTION NO. 031 series of 2024**

WHEREAS, the Municipality of Paniqui advertised the Invitation to Apply for Eligibility and to bid of the *Supply and Delivery of Hospital Laboratory Reagents (3<sup>rd</sup> Quarter 2024)*, at the *Paniqui General Hospital, Brgy. Samput, Paniqui, Tarlac* by posting the notice of bidding in the PHILGEPS, Bulletin Board and other conspicuous place in the premises of the LGU continuously for 7 days;

WHEREAS, in response to the said advertisements, One (1) supplier submitted letter of intent and applications for eligibility. The supplier purchased bid documents and the lone bidder submitted its bid and was found eligible on July 11, 2024;

WHEREAS, the bidding documents were submitted on July 11, 2024 and the lone bidder passed the preliminary examination of bids;





**THIS AGREEMENT**, made this 14<sup>th</sup> day of JULY 2024 between the Municipality of Paniqui, represented by **HON. LEONARDO M. ROXAS**, (hereinafter called the "Entity") and **CEF PHARMACY** of Brgy. Samput, Paniqui, Tarlac (hereinafter called the "Contractor").

**WHEREAS**, the Entity is desirous that the Contractor execute the *Supply and Delivery of Hospital Laboratory Reagents (3<sup>rd</sup> Quarter 2024), at the Paniqui General Hospital, Brgy. Samput, Paniqui, Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for **Four Hundred Eight Thousand Five Hundred Thirty Pesos Only (Php 408,530.00)** by the Contractor for the execution and completion of such Works with the contract duration of Fourteen (14) days.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - (i) Eligibility requirements, documents and/or statements;
  - (j) Performance Security;
  - (k) Notice of Award of Contract and the Bidder's conforme thereto;
  - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


