### **CONTRACT OF AGREEMENT**

THIS AGREEMENT, made this 29<sup>th</sup> day of NONEMBER 2024 between the Municipality of Paniqui, represented by HON. LEONARDO M. ROXAS, (hereinafter called the "Entity") and CEF PHARMACY of Brgy. Samput, Paniqui, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Procurement of various Drugs & Medicines for RHU-I, RHU-II and PGH (4<sup>th</sup> Quarter 2024), LGU-Paniqui, Tarlac (hereinafter called the "Works") and the Entity has accepted the Bid for One Million Two Hundred Thirty Seven Thousand Three Hundred Sixty One & 90/100 Pesos Only (Php 1,237,361.90)* by the Contractor for the execution and completion of such Works with the contract duration of Fourteen (14) days.
