### CONTRACT OF AGREEMENT

THIS AGREEMENT, made this 222nd day of November 2024 between the Municipality of Paniqui, represented by HON. LEONARDO M. ROXAS, (hereinafter called the "Entity") and GREGMAN'S SPORTS of 7065 7th St., Fairlane Subd., Brgy. San Vicente. Tarlac City (hereinafter called the "Contractor").
