CONTRACT OF AGREEMENT

THIS AGREEMENT, made this _15th day of NOVEMBER between the Municipality of Paniqui, represented by HON. LEONARDO M. ROXAS, (hereinafter called the "Entity") and EVERYBODY'S TRADING & GENERAL MERCHANDISE of Purok 1, Brgy. Balayang, Victoria, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Procurement of various Non-*Food Items to be used for Disaster Operation, MSWDO, LGU-Paniqui, Tarlac (hereinafter called the "Works") and the Entity has accepted the Bid for Five Hundred Ninety Six Thousand Seven Hundred Fifty Pesos Only (Php 596,750.00) by the Contractor for the execution and completion of such Works with the contract duration of Fourteen (14) days.

 - (1) Other contract documents that may be required by existing laws and/or the Entity.

The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
