WHEREAS, the bidding documents were submitted on January 23, 2025 and the lone bidder passed the preliminary examination of bids;


WHEREAS, the bid proposal of the bidder was found to be substantially complying:





CONTRACT OF AGREEMENT

THIS AGREEMENT, made this _____ day of _____ between the Municipality of Paniqui, represented by **HON. LEONARDO M. ROXAS**, (hereinafter called the "Entity") and **EVERYBODY'S TRADING & GENERAL MERCHANDISE** of Purok 1, Brgy. Balayang, Victoria, Tarlac (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor execute the *Procurement of Forty (40) Units Printer, MSWD Office (40 Child Development Center), LGU-Paniqui, Tarlac* (hereinafter called the "Works") and the Entity has accepted the Bid for **Three Hundred Ninety Nine Thousand Six Hundred Pesos Only (Php 399,600.00)** by the Contractor for the execution and completion of such Works with the contract duration of Thirty (30) days.

 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, this Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.




